## **CERTIFICATION BY MEMBERS EMPLOYING STAFF ON ROYAL PERTH YACHT CLUB PREMISES**

Members who wish to employ staff to work on their craft berthed at Royal Perth Yacht Club premises must complete the Certification below before the staff member will be allowed access to the Club grounds.

### **INSURANCE REQUIREMENTS**

Access to the Royal Perth Yacht Club Premises is strictly contingent on contractors fulfilling ALL of the following insurance requirements:

1. **Workers Compensation**  
Or  
**Personal Accident Insurance** (for sole traders)
  
2. **Public Liability Insurance** with an indemnity limit of not less than \$10 million.  
Or  
**Ship Repairers Liability Insurance** with an indemnity limit of not less than \$10 million.

### **SAFE WORK PRACTICES**

You are required to observe the safe work practices requirements of the Occupational Health, Safety and Welfare Act 1984, the Occupational Health, Safety and Welfare Regulations 1988, appropriate Australian Standards and Codes of Practice approved by State and Federal Occupational Health and Safety Commissions, as they apply to your tasks.

- In particular, if you or your employees are required to use toxic or dangerous chemicals, paints and cleaning agents, etc., you are to provide the necessary protective clothing and breathing apparatus and insist on and supervise its use.
- You are to ensure that you and your employees are trained and supervised in the safe use of all equipment or tools required to carry out your tasks.
- You are to ensure that you and your employees observe all safe work practices in relation to working in confined spaces.
- You are required to insist on, and supervise, the observance of all safe work practices relating to the above requirements.
