
In accordance with Club By-Laws Section 2, clauses 2.3 and 2.4, I have attached the following CURRENT documents:

PEN OCCUPANCY CONDITIONS

1. Occupancy conditions are defined in Club By-Law, Section 4, Marinas and Hardstand Areas.
2. No boat may occupy a pen until it has been registered with the Club.
3. No boat may occupy a pen until the owner has provided the Club with Proof of Ownership (DOT registration), a valid Certificate of Third Party Insurance with Third Party Cover of not less than \$10m.
4. Overall vessel length includes all fixtures extending beyond the bow and stern of the vessel.



5. A Pen Occupancy Deposit equal to 1.3 times the applicable annual pen rental will be charged to all first time Pen occupiers. The charge will also apply to existing pen holders who, by their request, move to a new pen.
6. Pens are not transferable on sale of vessel.
