2.	No boat	No boat may occupy a hardstand until it has been registered with the Club.					
3.	No boat may occupy a hardstand bay until the owner has provided the Club with Proof of Ownership (DOT registration), a valid Certificate of Third Party Insurance with Third Party Cover of not less than \$10m.						
4.	4. A Hardstand Occupancy Deposit equal to 1.3 times the applicable annual hardstand rental will be charged to all first time Hardstand occupiers. The charge will also apply to existing pen holders who, by their request, move to a new hardstand bay.
